

# MAINE STAR COONS CATTERY

## KITTEN PURCHASE AGREEMENT

---

This Agreement is entered into between Maine Star Coons Cattery (Breeder) and the Buyer, and becomes effective upon payment of adoption and/or purchase funds. By proceeding with the purchase and/or adoption funds, Buyer acknowledges full understanding and agreement to all terms outlined below.

### 1. INCLUSIONS

- Veterinary booklet including exam findings, tags, and certificates
- Vaccinations: 1st HCP; 2nd HCP; 3rd HCP and Rabies
- Deworming (age appropriate)
- Microchip
- TICA Breeder Registered Litter Slip
- One (1) year congenital life guarantee
- Thirty (30) days Trupanion pet insurance
- Purina One Kitten dry food starter bag
- Kitten toy

### 2. PAYMENT TERMS & PICK-UP CONDITIONS

Kitten must be picked up on the agreed date. Boarding fees of \$10 per day apply for delays. All pet kittens must be paid in full at 18 weeks following spay/neuter and Rabies vaccination. Failure to remit full payment on the set date results in forfeiture of all paid funds. Additional veterinary costs due to delayed pick-up are Buyer's responsibility. Terms are firm and non-negotiable.

### 3. NON-REFUNDABLE FUNDS

All funds paid are NON-REFUNDABLE. Funds may transfer to another kitten of same Queen or similar breeding class, subject to breeder approval. Gender changes require written approval and may incur fees. Waiting list timelines are not guaranteed due to breeding variables.

## **4. HEALTH GUARANTEE**

Breeder liability is limited to replacement of equal value and never exceeds purchase price.  
One (1) year congenital/genetic guarantee including heart defects (with confirmed diagnosis).  
Does not cover dental issues, entropion, intestinal occlusions, accidental injuries, or stress-related illnesses.  
Infectious diseases including Calicivirus, Herpesvirus, Coronavirus, Chlamydia, Mycoplasmosis are excluded.  
Three-week quarantine required if other animals present.  
Necropsy required for claims involving death within guarantee period.

## **5. SHIPPING & DELIVERY**

All shipping costs are Buyer's responsibility and non-refundable.  
Breeder assumes no liability once kitten is released to courier/airline.  
Buyer accepts inherent risks of long-distance purchase.

## **6. PHOTOS & UPDATES**

Breeder provides updates at discretion. Photos are not provided upon request.  
Weekly updates are typical but not guaranteed.  
Buyer responsible for protecting private images from misuse.

## **7. DECLAWING**

Declawing voids entire health guarantee due to risk of long-term physical and behavioral harm.

## **8. LIFETIME RESPONSIBILITY**

Buyer agrees not to lease, abandon, or surrender kitten to pet shop, shelter, or research facility.

Rehoming requires breeder approval or return to breeder at Buyer's expense.  
Breeder may reclaim kitten for neglect, abuse, or contract violation.

## **9. HOUSING REQUIREMENTS**

Indoor-only home required. No free roaming outdoors.  
Supervised harness use permitted.  
Breeder assumes no liability for vehicle or environmental incidents.

## **10. CONFIDENTIALITY**

Information related to breeder and cattery must remain confidential.  
Public defamation releases breeder from all contractual obligations.
